- If your application for membership is rejected by the Committee: You may give notice of your intention to appeal within 14 days of being advised of the rejection. The Club, in a general meeting, or no later than the next annual general meeting, must confirm or set aside the decision of the Committee rejecting your application, after giving you a reasonable opportunity to be heard or to make written representations to the general meeting.
